Our guest speaker at the general meeting was Mrs. Edwige Cathey. She is employed by the Harris County Tax Office, Outreach Dept. She shared important information with the attendees. Some items discussed were: (1) How is my property tax bill calculated? (2) How do I apply exemption if I qualify? (3) Tax Ceiling, for people who are over 65 or disabled. (4) Local Tax Limitation, for homeowners who are over 65 or disabled that meet Social Security disability guidelines. (5) Tax Deferrals and (6) Payment plans for delinquent taxes & Pre-payment Plans. She stated Harris Co. Tax Office has a FREE Tax Property workshop; the workshop is for 45 minutes. Mrs. Cathey gave everyone handouts with more services provided by the tax office.
